#### Northeast High-Level Radioactive Waste Transportation Task Force Fall Meeting October 26-27, 2022 at the Hyatt Regency New Brunswick 200 Neilson Street, New Brunswick, NJ 08901

The Fall meeting of the Northeast High-Level Radioactive Waste Transportation Task Force was held October 26-27, 2022 at the Hyatt Regency in New Brunswick, New Jersey. The meeting began with opening remarks and introductions by Co-chair Jerry Humphreys. At this meeting an election to fill the two year term of Co-chair Jerry Humphreys seat was to be held, however Task Forces rules require 7 of the 10 states to be present to hold a vote. Therefore it was agreed that co-chair nominations will be held via a virtual meeting by the end of the year and an anominous vote will be held via Survey Monkey.
