SUPPORTIVE HOUSING PROGRAMS

HUD Supportive Housing Programs (examples)

- Section 811 Project Rental Assistance (PRA) Program
 - Funds affordable, integrated supportive rental housing for extremely low-income non-elderly people with disabilities; implemented by state housing agencies in partnership with state Medicaid and/or health and human services agencies
- Section 202 Supportive Housing for Older Adults
 - Funds supportive housing properties owned by nonprofits to provide affordable supportive rental housing for very low-income elderly persons.
- Mainstream Voucher Program
 - Housing Choice Vouchers targeted to very low-income non-elderly people with disabilities and administered by public housing agencies (PHAs).

PD&R Studies on Supportive Housing (examples)

- <u>Supportive Services Demonstration and Evaluation: Testing Integrated Wellness in Supportive Housing (IWISH)</u>
 <u>Model</u>
 - Large, cluster randomized-controlled trial that leverages HUD-assisted properties as a platform for the coordination and delivery of services to better address the interdependent health and supportive service needs of its older residents.

Evaluation of the Section 811 Project Rental Assistance program

- Multi-year project to assess the implementation and effectiveness of this new model of housing assistance for extremely low-income non-elderly adults with disabilities.
- Understanding Rapid Re-Housing Study
 - Multi-year project undertaken to address important questions about rapid re-housing (RRH) assistance and how it is administered by organizations and experienced by program participants in communities around the country.

Service Coordinator Program

- Service coordinators assist elderly individuals and persons with disabilities in obtaining the supportive services they need to live independently and prevent premature institutionalization at properties.
- The service coordinator plays a critical role in supporting HUD-assisted multifamily housing as a platform for financial security, physical security, social connections, and the delivery of long-term community based supportive services, especially for vulnerable populations such as the elderly and persons with disabilities.
- Funding covers the service coordinator salaries and fringe benefits, training, quality assurance, and relevant administrative expenses.
- Property that may have a service coordinator are 202 Project Rental Assistance Contract (PRAC), Section 202 Direct Loan, Section 221(d)(3) Below-Market Interest Rate (BMIR), Section 236, and certain Section 8 programs that primarily serve seniors.



Service Coordinator Core Functions

• Conducting comprehensive, non-clinical assessments of residents for wellness and social needs.

• Helping residents to identify, access, and coordinate services.

 Monitoring the receipt and follow through of services, including encouraging and motivating residents to engage with providers and participate in their own care/services management.

• Proactively developing and arranging educational or preventative health programs and services.

• Developing and sustaining partnerships with local agencies and organizations serving older adults.

• Maintaining an up-to-date resource directory with all local service providers.
